## Privacy Policy

This Privacy Policy describes the practices of SOMA STUDIO regarding the collection, use, and protection of personal data of users of the website [www.somastudio.xyz](http://www.somastudio.xyz).

### 1. Data Collected

We collect personal data when you use our contact form or subscribe to our newsletter. The data collected may include:

First and last name

Email address

Company

Phone number (if applicable)

Any other information you choose to provide in the message of the contact form

### 2. Use of Data

The personal data collected are used to:

Respond to your contact requests and provide the requested information

Send you our newsletter if you have subscribed to it

Improve our services and communication with our clients

### 3. Legal Basis for Processing

The processing of your personal data is based on your consent (Article 6.1.a of the GDPR) when you fill out the contact form or subscribe to our newsletter.

### 4. Data Recipients

The personal data collected are intended solely for SOMA STUDIO and are not transmitted to third parties without your prior consent, except when required by law.

### 5. Data Retention Period

Your personal data are retained for a duration of:

Three (3) years from the last contact initiated by you for prospective clients

### 6. Data Security

We implement appropriate technical and organizational security measures to protect your personal data against any destruction, loss, alteration, or unauthorized disclosure.

### 7. Your Rights

In accordance with applicable regulations, you have the following rights regarding your personal data:

Right of Access: Obtain confirmation whether or not your data are being processed and, when they are, access said data.

Right to Rectification: Obtain the correction of inaccurate personal data concerning you.

Right to Erasure: Obtain the deletion of your personal data within the limits permitted by law.

Right to Restriction of Processing: Obtain the limitation of processing in certain cases provided by law.

Right to Object: Object at any time to the processing of your personal data for direct marketing purposes.

Right to Data Portability: Receive the personal data you have provided to us in a structured, commonly used format.
